Ben's Lighthouse Fortifying Newtown's Resilient Community

In June 2013, a 20-foot-tall, green and white lighthouse stood outside of Trinity Episcopal Church, Newtown. The tower served as an invitation for community members to participate in a nautically-themed day of family activities. Hundreds of participants were greeted by an array of music, dancing and art projects. There was even an interactive seascape constructed just in front of the church's chancel, complete with waves, fishing nets, telescopes and more lighthouses.

The Lighthouse Festival was the first event held by Ben's Lighthouse, an organization supported by Trinity Church to honor the memory of Ben Wheeler and other children killed at Sandy Hook Elementary in 2012. The organization's

Episcopal Diocese of Mississippi

The Diocese of Mississippi is working to assist residents of Columbia, MS affected by December tornados.

inaugural event took place on the 6-month anniversary weekend of the shootings. One supporter said, "We took an otherwise uncomfortable weekend and created thousands of smiles."

In the two years following the tragedy in Newtown, CT, The Episcopal Church in Connecticut and Episcopal Relief & Development have partnered to support Ben's Lighthouse and Trinity Episcopal Church. During that time, Ben's Lighthouse has emerged as a leader in fostering community resilience. Working with the understanding that "helping is healing," Ben's Lighthouse provides opportunities for relationship building, creative expression and service work. Notably, Ben's Lighthouse sponsored a service trip where 20 teens were able to contribute to the rebuilding efforts after floods damaged a community in Loveland, CO. On their trip, participants had the opportunity to connect with survivors of shooting in Littleton, CO. Upon their return, the organization held a discussion forum so that the broader community could listen to the youths' reflections on the trip. Some of the Newtown participants still text with their mentors in Colorado, developing lasting healing relationships.

However, despite an outpouring of initial support, Newtown community members report that there are increasing and unmet needs. Many of the early support agencies are no longer active in the area.

Focused on addressing these challenges, Program Manager Kelly Paredes plans to promote opportunities for engagement that utilize a vast array of local talents. Volunteers and staff are working to support the mission of fostering empathy, self awareness and volunteerism within the community. So far, planned activities for 2015 include the formation of Ben's Lighthouse Club to reflect on community healing, the continuation of a popular mentorship program, a winter family fun festival and additional service projects.

Tips & Lessons: Mobilizing Your Network of Supporters After a Disaster

On April 27, 2014, tornadoes tore through central Arkansas, killing 16 people and causing significant property damage in several communities. Unfortunately, Arkansas is no stranger to severe weather. Because tornados were a likely hazard in their area, the Arkansas Episcopal Disaster Relief Team had met for months to prepare, and were ready to launch their response to the deadly storms.

In collaboration with diocesan leadership, other local responders and Episcopal Relief & Development, Disaster team members were able to assess the impact of the storm and determine where their efforts were most needed. Volunteers from seven churches responded by providing gift

Episcopal Diocese of Colorado

Episcopal Church in Connecticut

The Diocese of Oklahoma is working with congregations and long-term recovery groups around the state to meet the needs of vulnerable people following tornados in the spring of 2013

cards, offering spiritual support and running drop-in centers where individuals could connect with multiple forms of assistance. Youth groups were set to work removing debris from their communities. Response coordinators connected with bilingual volunteers to make a concerted effort to ensure that undocumented and non-English speakers were able to access services necessary to rebuild. A local church in Conway opened their doors to individuals in need of temporary housing. Now, after extensive relief efforts, the Arkansas Episcopal Disaster Relief Team has shifted its focus to long-term recovery so that it can continue to support the communities impacted by the storm.

The Arkansas Disaster Relief Team was able to initiate such thoughtful and enduring tornado response because it was able to mobilize a large constituency of passionate supporters before and during the disaster.
